Pursuant to Article 145 (paragraph 2) of the Constitution of the Republic of Kosovo, taking into account articles 8, 9, 10 and 11 of the Law No. 06/L - 113 on the Organization and Functioning of State Administration of the Independent Agencies, (Official Gazette, No. 7/01 March 2019), based on Article 8 (paragraph 1.4) article 15, Annex 11 of the Regulation (GRK) - No. 02/2021 on the Areas of the Administrative Responsibilities of the Prime Minister's Office and the Ministries (30.03.2021), and Article 20 (paragraphs 1,4 and 5) of the Law No. 03/L - 042 of the Plant Protection Products (Official Gazette No. 44, date 22.12.2008) as well as based on recommendation of the Commission on assessment and authorization of the Plant Protection Products, with Ref. 04-382/23, of the date 31.07.2023, Minister of the Ministry of Agriculture, Forestry and Rural Development, issues the following:

DECISION

On the Inclusion in the register and permitting the authorization to use plant protection product

1. The import, placement in the market and the authorization to use plant protection product -ESTIUOIL of producer "Exclusivas Sarabia S.A", Spain from its representative "EcoTech-Pest Control" SH.P.K, Suhareka shall be permitted.

2. TYPE OF PRODUCT:

Insecticides, Acaricides

3. CONTENT OF ACTIVE SUBSTANCE: Unrefined mineral oil

Number CAS 8042-47-5.....790 g/l

4. USE:

ESTIUOIL is a product with a high concentration of paraffinic mineral oil. ESTIUOIL has a high insecticides power for the control of all types of insects and spiders to a high degree in the quiescent winter phase, which it acts through the contact that lies on the surface of the insect preventing its breathing. It also blocks the development of insect's eggs and spiders to prevent gas exchange. The penetration of the oil into the insect also affects various physiological processes. Dosage and method of use:

Carry out the treatment (1 per year) before vegetation.

Citrus fruits (orange, lemon, tangerine, grapefruit), against spiders (Panonychus citri, Eutetranychus banki, Tetranychus urticae) and cochineals (Aonidiella aurantii, Aspidiotus nerii,

Lepidosaphes spp, Parlatoria pergandii). Use in doses: 1-1,5L/100 lit of water, distributed at 1000-2000 lit/water/ha.

Fruit trees (apple, pears, plums, etc.), against pests (*Quadraspidiotus pemiciosus*), with doses; 0.75-1lit/100 lit/water spending 500-100 lit water per hectare.

Stone fruit: (nectarine peach, apricot, plum, cherry) against pests (*Quadraspidiotus pemiciosus*, *Pseudaulacaspis pentagona*). Use in a dose of 0,75-1lit/100lit/water, distributed with 500-1500 L/ha water.

Preparation: shake the product before dissolving and during spraying it must be constantly mixed with the special part of the atomizer.

5. PACKING QUANTITY FOR IMPORT:

100ml,250ml,500ml,1L,5L,10L,25L,600L,800L.

6.REMARK:

The product can be mixed with products based on Sulphur, polysulphides, captan or folpet. Do not apply the product before at least 40 days have passed since the treatment with sulphur, polysulfides, captan or folpet, but it is mixed with a copper base.

PHYTOTOXICITY: Do not carry out treatments on hot and dry days.

- 9. PLACE OF SELLING: In the whole territory of the Republic of Kosovo.
- 10. The plant protection product authorized by point 1 of this decision is allowed to be imported into the Republic of Kosovo, until the deadline as defined in the registration certificate, based on the EU Pesticides/Active Substances Database, while circulation and its use is allowed according to article 26 paragraph 3 of Law No. 03/L-042 of Plant Protection Products.

11. This decision shall enter into force on the day of signature.
